3) I authorise High Court Writ Recovery to sign any court form necessary for the purpose of enforcing my judgment including County Court Form N244 or any Statement of Truth required in support of my application to enforce my judgment.
4) I authorise the County Court to return the completed N244 direct to High Court Writ Recovery and /or to correspond directly with High Court Writ Recovery regarding my application.
5) I confirm that the judgment is not based upon a Regulated Agreement under the Consumer Credit Act 1974, unless the judgment debt is £25,000 or more.
6) I represent that I am authorised to provide these instructions on behalf of the claimant and will be bound by the terms of this Agreement.
7) Where our agents have been forced to withdraw from an enforcement action due to circumstances outside of our control, for any reason whatsoever including but not limited to the Client standing us down on site, the site being vacant on our attendance or the Police issuing instructions to withdraw, our fees for attendance and time spent on site remain payable as quoted.
8) Where our planned attendance is delayed or cancelled by you or any other party, once our Enforcement Agents have already mobilised to site but not yet arrived, we reserve the right to charge 50% of any fees we have already quoted to you for the aborted attendance.
9) In the event an agent has attended or is in the process of attending to execute the eviction, and it is subsequently established that the occupant is subject to Breathing Space without being prior informed during business hours (9:00-17:00) the day before eviction. You will be responsible for an abortive fee, equal to our eviction fee for attending and dealing with the matter, together with any locksmith charges for attending.
<b>NB:</b> Late payment charges will be applied to all our overdue invoices in accordance with the Late Payment of Commercial Debts (Interest) Act 1998 (As Amended).
